RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT
(This is a legal document—please read carefully)

IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN "THE EVENT(S)" (WHICH SHALL INCLUDE, BUT NOT BE LIMITED TO, ANY SOCCER TRAVEL, SOCCER CAMP, SOCCER CLINIC, TRYOUT, SOCCER PRACTICE, SOCCER GAME OR COMPETITIVE SOCCER SPORTING EVENT HELD AT ANY TIME BETWEEN THE DATE LISTED ABOVE AND DECEMBER 31, 2010) AND IN CONSIDERATION OF BEING ALLOWED TO ENTER INTO "THE RESTRICTED AREA" (HEREIN DEFINED AS ANY PLAYING FIELD, INFIELD, STADIUM, PARKING LOT, LOCKER ROOM, WALKWAY, CONCESSION, GYMNASIUM OR ANY AREA APPURTENANT THERETO, AS WELL AS ANY AREA IN WHICH ANY ACTIVITY RELATED TO "THE EVENT(S)" SHALL TAKE PLACE):

1. THE UNDERSIGNED ACKNOWLEDGES THE INHERENT RISKS OF BODILY INJURY , DEATH, OR PROPERTY DAMAGE ARISING FROM HIS/HER PARTICIPATION IN ANY SOCCER TRAVEL, SOCCER CAMP, SOCCER CLINIC, SOCCER TRYOUT, SOCCER PRACTICE, SOCCER GAME OR COMPETITIVE SOCCER SPORTING EVENT, AND HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE OR MAKE CLAIMS AGAINST REAL MARYLAND, F.C., MARYLAND SOCCER ENTERPRISES, LLC, THE MARYLAND SOCCER PLEX, THE MARYLAND SOCCER FOUNDATION, RICHARD MONTGOMERY HIGH SCHOOL, MONTGOMERY PUBLIC SCHOOLS, REAL SPORTING GIJON FOOTBALL CLUB, THEIR PARENT(S), SUBSIDIARIES, AND AFFILIATED CORPORATIONS, AND ALL DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, AND VOLUNTEERS OF THE SAME, AND ALL PROMOTORS, ANY SANCTIONING ORGANIZATION OR ANY SUBDIVISION THEREOF, PARTICIPANTS, OFFICIALS, PLAYERS, COACHES, CAMP STAFF, CLINIC STAFF, TEACHERS OFFICIALS, TRAINERS, MEDICAL PERSONNEL, RESCUE PERSONNEL, PERSONS WHO GIVE DIRECTIONS, SPONSORS, OWNERS, DIRECTORS, ADVERTISERS, INSURERS, UNDERWRITERS, CONSULTANTS, OR OWNERS OF THE PREMISES WHERE "THE EVENT(S)" SHALL OCCUR, AND ANY OTHER PERSON (S), ALL FOR THE PURPOSES HEREIN REFERRED TO AS "THE RELEASEES", FROM ALL LIABILITY to the undersigned, his/her personal representatives, heirs, assigns and next of kin, for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death or the undersigned, whether caused by the negligence or gross negligence of the "RELEASEES" or otherwise while the undersigned is participating, observing, competing, and/or officiating, in "the EVENT(S)" or while upon "THE RESTRICTED AREA".

2. THE UNDESIGNED (ON HIS/HER BEHALF AND ON BEHALF OF HIS/HER PERSONAL REPRESENTATIVES, HEIRS, ASSIGNS, AND NEXT OF KIN) AGREES TO INDEMNIFY AND HOLD HARMLESS THE "RELEASEES", and each of them, from any loss, liability, damage, or cost incurred while the undersigned is participating, observing, competing, and/or officiating in "the EVENT(S)" and/or arising from any incident taking place in or upon "THE RESTRICTED AREA".

3. THE UNDESIGNED (ON HIS/HER BEHALF AND ON BEHALF OF HIS/HER PERSONAL REPRESENTATIVES, HEIRS, ASSIGNS, AND NEXT OF KIN) HEREBY ASSUMES FULL RESPONSIBLITIY FOR ALL RISK OF BODILY INJURY, DEATH, AND PROPERTY DAMAGE DUE TO THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE RELEASEES, OR OTHERWISE while participating, observing, competing, and/or officiating in "THE EVENT(S)" and/or arising from any incident taking place in or upon "THE RESTRICTED AREA".

The undersigned acknowledges and agrees that the foregoing RELEASE and WAIVER OF LIABILITY and INDEMNITY AGREEMENT is intended to be as broad and inclusive as permitted by the laws of the State in which "the EVENT(S)" is conducted, and that if any portion thereof is held invalid, it is agreed that the balance thereof shall continue in full force and effect, and that the same has been signed VOLUNTARILY and that no representations, statements, or inducements, oral or written, apart from the foregoing agreement, have been made.
